### **FY 2016-2025 TIP Amendment #3 Summary Sheet**

*For review, public hearing, and approval.*

- **#B-4943 SR 1616 Bahama Road Bridge:** The NCDOT has requested to delay right-of-way from FY2016 to FY2017 and construction from FY2017 to FY2018 to allow additional time to complete the flood study and select an engineering firm. Pgs. 1-2.
- **#C-5181 Jones Creek Greenway:** The NCDOT has requested to delay construction from FY2016 to FY2017 and implementation from FY2017 to FY2018. Pgs. 3-4.
- **#C-5184 Riverwalk Trail:** The NCDOT has requested to delay right-of-way from FY2015 to FY2016 to allow more time for town to complete final right-of-way plans. Pgs. 5-6.
- **#C-5571 Passenger Rail Projects (NCRR):** The NCDOT has requested to add implementation in FY2017 that was not previously programmed. Pgs. 7-8.
- **#U-4726 Downtown Multi-Use Path (Carrboro):** The DCHC MPO is requesting to cancel this TIP ID # because the project received a different TIP #C-5605A. Pgs. 9-10.
- **#EB-4707A Old Durham-Chapel Hill Road (Chapel Hill):** The DCHC MPO received a request from Chapel Hill to add STP-DA and TAP-DA funding to this project for construction in 2017. This project was selected to receive the funding through the MPO's competitive process for regional bicycle and pedestrian projects. Chapel Hill provided a project status update in the spring 2016 and indicated that right-of-way should be delayed from FY2016 to FY2017 and construction should be scheduled for both FY2017 and FY2018. - **#EL-4828 Morgan Creek Greenway (west) (Carrboro):** The DCHC MPO received a request from Carrboro and NCDOT to reschedule PE/design from FY2015 to FY2016 and construction from FY2016 to FY2017 and FY2018. Pgs. 13-14.
- **#I-5702C I-40 Managed Lanes from Wade Avenue to US 64 (CAMPO):** The CAMPO is requesting to cancel this break of the project. A portion of the parent project (I-5702) is within the DCHC MPO Boundary so DCHC MPO also needs to cancel this project from the DCHC MPO TIP. Pgs. 15-16.
- **#P-2918 Piedmont Corridor Passenger Rail (NCDOT):** The NCDOT has requested add operations in FY2017 that were not previously programmed. Pgs. 17-18.
- **#SR-5001 Statewide Safe Routes to School Infrastructure (NCDOT):** The NCDOT has requested to add construction in FY2016 and FY2017 that were not previously programmed. Pgs. 19-20.

- **#TA-4726A Chapel Hill Transit Replacement Buses:** The DCHC MPO received a request from Chapel Hill Transit to move the STP-DA funding (\$973,331) from Prior Year to FY2017 and to indicate that the STP-DA funding is being flexed to FTA-5307 funding. This is the first time that the DCHC MPO is able to show the flexing of funds from STP-DA to 5307 and showing the flexing of funding in the MPO's TIP will help DCHC MPO better support transit operators. - **#TA-4923 GoDurham Replacement Buses:** The DCHC MPO received a request from GoDurham to add capital in FY2017 – FY2022 not previously programmed. Pgs. 23-24.
- **#TA-5019A GoDurham Replacement Paratransit Vehicles:** The DCHC MPO received a request from GoDurham to update the funding amount shown in 2016. STP-DA funding for the NC-95-XO74 grant is split across a couple of TIP projects and needed to be adjusted. Pgs. 25-26.
- **#TA-5144 GoDurham Battery Replacement (Bus Purchases):** The DCHC MPO received a request from GoDurham to add capital in FY2017 not previously programmed and to modify the name of the project. Pgs. 27-28.
- **#TA-5193 GoTriangle Replacement Vehicle:** The DCHC MPO received a request from GoTriangle to add a new project to the TIP and STIP for the purchase of one replacement vehicle with 5339 and 5307 funding. Pg. 29.
- **#TA-5195 GoTriangle Replacement Vehicle:** The DCHC MPO received a request from GoTriangle to add a new project to the TIP and STIP for the purchase of one replacement vehicle with JARC funding. Pg. 30.
- **#TA-5199 Bus Replacement (GoDurham):** The DCHC MPO received a request from GoDurham to add a new project TIP and STIP. GoDurham will purchase replacement buses. GoDurham was awarded CMAQ funding in 2015 for this project. Previous TIP #C-5605B. Pg. 31.
- **#TA-5200 Bus Replacement (Chapel Hill Transit):** The DCHC MPO received a request from Chapel Hill Transit to add a new project TIP and STIP. Chapel Hill Transit will purchase replacement buses. Chapel Hill Transit was awarded CMAQ funding in 2015 for this project. Previous TIP #C-5605C. Pg. 32.
- **#TA-5218 GoTriangle Bus Replacement:** The DCHC MPO received a request from GoTriangle to add a new project to the TIP and STIP for the purchase of five replacement buses with 5307 funding. Pg. 33.
- **#TA-5219 GoTriangle Bus Replacement:** The DCHC MPO received a request from GoTriangle to add a new project to the TIP and STIP for the purchase of three replacement paratransit vehicles and related equipment with 5307 funding. Pg. 34.
- **#TA-5225 GoTriangle Bus & Vanpool Replacement:** The DCHC MPO received a request from GoTriangle to add a new project to the TIP and STIP for the purchase of one replacement bus and five vanpool vehicles. Pg. 35.
