# MEMORANDUM

**RE:** **MPO BOARD DIRECTIVES + IIJA UPDATE + STAFF REPORT**

This memorandum updates the board on their directives, the 2021 Infrastructure Investment and Jobs Act's programs, and summarizes DCHC MPO Unified Planning Work Program (UPWP) tasks.

## 1. MPO BOARD DIRECTIVES

11-4-20	Develop a strategy to move forward on the 15/501 Corridor Study that addresses concerns about bicycle and pedestrian treatments along the corridor as well as additional outreach to local stakeholders.	<i>Underway.</i> NCDOT began an express design effort to reconsider the corridor interchange with I-40. Staff advised NCDOT consultant that non-motorized and transit access were critical, and that project analysis should involve local stakeholders.
10-13-21	Investigate potential options for a racial equity policy and/or framework for DCHC MPO.	<i>Pending.</i> Staff initiated discussion with different advocacy resources in preparation for the legislative long session. We will update more specific actions in January .
12-15-21	Investigate the possibility of conducting a highway safety plan or other options for improving highway safety within the MPO.	<i>Underway.</i> MPO staff submitted a Safe Streets for All grant application. The 23-24 UPWP will include a safety specific task.
4-13-22	Staff should address outstanding items regarding the Triangle Regional Model TRM) and work with the TRM team at ITRE to address those concerns. Staff should report back to the Board in spring 2023.	<i>Underway.</i> MPO staff are working with the four partner agencies and ITRE staff to address concerns.
5-11-22	Develop a set of specific recommendations for the legislative delegation to consider based on the DCHC-CAMPO adopted policy priorities for the 2023 General Assembly session.	<i>Underway.</i> Engaged with transportation policy advocates to review previous long session priorities and will bring forward ideas in January.

**2. INFRASTRUCTURE INVESTMENTS AND JOBS ACT UPDATE**

On November 6, 2021, Congress passed the Bipartisan Infrastructure Deal (Infrastructure Investment and Jobs Act) (IIJA), a once-in-a-generation investment in national infrastructure and competitiveness. Among the IIJA's goals are several transportation-related investments in electric vehicles and infrastructure, passenger rail, airports and ports, public transit, and roads and bridges.

The funding for these programs will be distributed by state through formula grants and competitive grants, each with their own timeline and application requirements. This standing memo seeks to update the MPO Board and DCHC MPO jurisdictions regularly to grant and funding opportunities as they arise.

**II – B – 1: Targeted Planning**

  - ✓ Membership requested the MPO explain how to advance the western Triangle Bikeway from concept to construction. Staff reviewed the implementation recommendations from the Triangle Bikeway Study and consulted with CAMPO regarding the current design project for the eastern Bikeway. Western section next steps include identifying funding and capacity to manage the design process. Wake County and the RTP Foundation financially support the eastern design project. CAMPO will manage the design consultant contract. Their strategy does not use federal funding for the design phase but

will seek federal funding for implementation. They hope NCDOT will manage construction because the majority of the project is within NCDOT right-of-way.
