We have received HILC funds from Division 8 for \$17,500 to partially cover the local match, and the county will providing the rest. Compiled into one total project, we will be giving \$139,866 to NCDOT to help carry out 3 bike/ped safety projects around the county. The non-federal match required is \$34,966.50. These projects will require no ROW acquisition. Each of the four have been identified by NCDOT leaders as locations in need of improvements. Descriptions of the four individual safety projects can be found below.</p> <p>PEDESTRIAN SAFETY AT INTERSECTION OF MT. CARMEL CHURCH RD. AND GOVERNORS DR. Description: This project would extend the sidewalk on the north side of Governors Drive and mark a crosswalk across Governors Drive, connecting the three current sidewalks. This project would also include new pedestrian walking signals. NCDOT already has TAP funding to implement the ramp work but needs an additional \$20k for updating the markings.
