5. **Amendment #13 to the FY2020-2029 Transportation Improvement Program (TIP)** [22-189](#)
Aaron Cain, LPA Staff

Amendment #13 to the FY2020-29 TIP adds two new bus purchase projects to the TIP that were funded through the North Carolina Volkswagen Settlement Phase 1 Transit and Shuttle Bus Program using Congestion Management Air Quality (CMAQ) funds provided through NCDOT and settlement funds for the local match. TIP Amendment #13 also adds Chatham County's STBG-COVID allotment to BL-0070, Chatham County Pedestrian Safety Projects, for the engineering phase. Additional routine changes from NCDOT are also included.

Because the bus purchases are in excess of \$1 million each, per the MPO's Public Involvement Plan, this amendment must be released for a 21-day public comment period.

DCHC MPO is preparing to release its annual call for projects for Surface Transportation Block Grant Direct Attributable (STBGDA), Congestion Mitigation Air Quality (CMAQ), Transportation Alternatives Program Direct Attributable (TAPDA) funds that are distributed annually by the MPO. In addition to these traditional funding sources, a new program has provided additional funds for the MPO to distribute: the Carbon Reduction Program (CRP).
