### 11. Orange County Transit Plan Update Adoption (15 minutes) Tom Altieri, Orange County

In response to the discontinuation of the light rail project in 2019, the Orange County BOCC initiated the process for updating the Orange County Transit Plan. Over the past two years, the project team has been developing the draft with input from the public and direction through a Policy Steering Committee (PSC) comprised of elected officials. At its November 1, 2022 meeting, the Orange County BOCC received positive recommendations from the PSC, Orange County Staff Working Group, and Orange Unified Transportation Board all recommending adoption of the Transit Plan. A public hearing was also held and no members of the public offered comment. After closing the public hearing, the Orange County BOCC adopted the 2022 Orange County Transit Plan Update to include a revised financial summary (attached) that allocates additional funding to the Chapel Hill Transit North-South Bus Rapid Transit (N-S BRT) project. The Carrboro Town Council approved a Resolution Endorsing Adoption of the 2022 Orange County Transit Plan Update, which is also attached.

At the October 12, 2022 MPO Board meeting, the Board received a detailed presentation from Orange County staff and recommended the release of the draft Plan for public comment (attached). The draft Orange County Transit Plan was released for public comment on October 17, 2022. The MPO received no public comments. A public hearing was held by the Orange Board of County Commissioners on November 1, 2022; no comments were made at the public hearing.

**TC Action:** Recommended that the MPO Board adopt the 2022 Orange County Transit Plan Update, including the revised financial summary, which incorporates additional funding for the Chapel Hill Transit North-South Bus Rapid Transit (N-S BRT) project.

### 12. <u>Durham and Orange Counties Transit Governance Study (30 minutes)</u>

In 2011 and 2012, respectively, Durham and Orange counties approved county-wide transit plans, which included a joint recommendation for the development of the Durham-Orange Light Rail Transit (D-O LRT) project. In 2013, an Interlocal Agreement (ILA) was developed and approved by each County Board of Commissioners, the DCHC MPO Board, and GoTriangle Board of Trustees. Upon the discontinuation of the D-O LRT project in 2019, it was realized that a new governance framework was necessary to guide the implementation of future county transit plans. This governance study was initiated in 2021 to create the new governance framework.

In the fall of 2021, this study invited many of you, as well as staff, to participate in initial small group interviews. From those interviews, the team learned about overall needs and the study process continued to allow for a facilitated workshop with elected officials from each of the transit plan governing boards. These needs were defined through five overall elements to be incorporated into a new governance framework: Representative, Equitable, Collaborative, Transparent & Accessible.

From these five elements, the elected officials helped to further weigh-in on just how much change was necessary to primary elements of the existing frameworks. The feedback provided leadership and guidance to develop draft alternatives for consideration in a new governance framework. Staff from all four parties to the existing governance frameworks attended joint workshops in March and April 2022. These workshops focused on critical elements that informed the foundation of what a new ILA could offer to all parties. Discussion focused on multiple alternatives of critical elements that comprise the following four areas: Membership, Voting Structures, Financial Planning, and Program & Plan Development.

In parallel with the Interlocal Agreement development, discussions with all parties to the agreements discussed critical elements that would require further definition or supportive guidance through supplemental policies & procedures and not be specifically codified in the ILA. These items include updated SWG Bylaws, Financial Policies, as well as incorporating plan implementation, administration, and management elements throughout. Throughout the summer of 2022, several multi-agency staff meetings were held to work through some of the finer details of the ILA. The result is a final Transit Governance Interlocal Agreement (ILA) for each County that reflects the study process goals and the five critical elements identified above.

The adoption of County ILAs began with Orange & Durham Counties, continues with the MPO, and GoTriangle will be the final party to receive and have opportunity take action to adopt before the end of 2022. The Orange Board of County Commissioners adopted the Orange ILA on November 1, 2022. The Durham Board of County Commissioners adopted the Durham ILA on November 14, 2022.

There are minor differences between the Orange and Durham ILAs adopted by each county. The attached addendum shows the differences between the two. The change in language was requested by GoTriangle staff as a clarification. That request was made after the draft Orange ILA was sent to the Orange BOCC, and was adopted in its original form. The Durham BOCC adopted its ILA with the updated language. The versions of each ILA presented to the MPO Board are the ones that were adopted in each county.

While the ILA adoption process for Durham and Orange Counties has moved forward with a recommendation from the TC at its November 2022 meeting, Orange County has requested that the MPO Board postpone consideration of approval of its ILA until its January 2023 meeting. Approval of the Durham County ILA by the MPO Board remains for consideration.

**TC Action:** Recommended, on a 14-2 vote, that the DCHC MPO Board adopt the Durham and Orange County ILAs.

**Board Action:** Adopt the Durham County ILA, and postpone adoption of the Orange County ILA until the January 2023 Board meeting.

## 13. Congestion Management Process (CMP) Updates (15 minutes) Yanping Zhang, LPA Staff Jaehoon Kim, LPA Staff

<u>22-124</u>

The congestion management process (CMP) is a systematic and regionally-accepted approach for managing congestion that provides accurate, up-to-date information on transportation system performance. It assesses alternative strategies for congestion management that meet State and local needs. Federal requirements state that the CMP shall be developed and implemented as an integrated part of the metropolitan transportation planning process. It is a continuous process and the MPO staff keeps working on the data collection and analysis as well as the system performance measures. Available system performance measures from 2018-2021 will be presented. A draft work plan is developed for FY2022 and FY2023, and MPO staff members propose to work together with consultants for developing congestion mitigation strategies and reports.

**TC Action:** Recommended that the MPO Board approve the CMP goals and objectives. **Board Action:** Approve the CMP goals and objectives.
