

RESOLUTION

ADOPTING A COMPREHENSIVE TRANSPORTATION PLAN FOR THE DURHAM-CHAPEL HILL-CARRBORO METROPOLITAN PLANNING ORGANIZATION (DCHC MPO)

The following resolution was offered by Board Member _____, seconded by Board Member _____ and, upon being put to a vote, was carried _____ on the _____ day of _____, _____.

WHEREAS, the Durham-Chapel Hill-Carrboro Metropolitan Planning Organization and the Transportation Planning Branch, North Carolina Department of Transportation, have actively worked to develop a Comprehensive Transportation Plan for the Durham-Chapel Hill-Carrboro MPO; and

WHEREAS, the MPO and the Department of Transportation are directed by North Carolina General Statutes 136-66.2 to reach agreement for a transportation system that will serve present and anticipated travel demand in the MPO; and

WHEREAS, it is recognized that the proper movement of transportation modes within and through the MPO planning area is a highly desirable element of the comprehensive plan for the orderly growth and development of the MPO; and

WHEREAS, it is recognized that the DCHC MPO Comprehensive Transportation Plan will replace the existing Chatham County, Durham County, Chapel Hill, Carrboro, and Hillsborough Thoroughfare Plans;

WHEREAS, after full study of the DCHC MPO Comprehensive Transportation Plan, the supporting documents presented, and following a public input process that included multiple workshops and a public hearing, the MPO Board feel it to be in the best interests of the MPO to adopt a plan pursuant to General Statutes 136-66.2;

NOW THEREFORE, BE IT RESOLVED: that the Durham-Chapel Hill-Carrboro MPO Comprehensive Transportation Plan maps, dated May 10, 2017, and report be approved and adopted as a guide in the development of the transportation system in the MPO planning area;

NOW THEREFORE, BE IT FURTHER RESOLVED: that the Durham-Chapel Hill-Carrboro MPO Comprehensive Transportation Plan maps, dated May 10, 2017, are hereby recommended to the North Carolina Department of Transportation for its subsequent adoption.
