Since these original letters were approved, the DCHC MPO received a letter from NCDOT signed by Debbie Collins, Director, Public Transportation Division, on June 10, 2016 indicating that "there is an agreement that NCDOT will be applying to FTA for those funds on behalf of Orange County. This will necessitate revising the Allocation Letter to identify North Carolina Department of Transportation PTD as the recipient on behalf of Orange County." Thus, the DCHC MPO is requesting that the four earlier Split Letters identified above be revised only for the allocation to Orange County according to Table II below so the NCDOT can proceed to complete and submit an FTA grant application for the funds on behalf of Orange County.
