5. **Durham County Transit Plan Update (10 mins)** [19-160](#)

The Durham County Transit Plan directs the allocation of Durham County transit tax revenue. The Plan was updated in 2017; however, due to the discontinuation of the Durham-Orange Light Rail Transit project, an update is currently underway. This presentation will provide the status and next steps in that process.

6. US 15-501 Corridor Study (15 minutes)[19-144](#)**Andy Henry, LPA staff****Leta Huntsinger, WSP (consultant)**

At the May 8, 2019, DCHC MPO Board Meeting, the MPO Board passed a motion to endorse 'Option B,' which was to expand the schedule and funding for the 15-501 Corridor Study in order to address the impacts of the discontinuation of the Durham-Orange Light Rail Transit (D-O LRT) project. The amount of additional time and budget had not yet been determined at the time of the meeting. Also during the MPO Board Meeting, there was discussion about how projects along that corridor, especially those related to Bus Rapid Transit (BRT), would be impacted as they are submitted through Strategic Planning Office of Transportation (SPOT) 6.0.

An update will be provided at the meeting.

7. Triangle Strategic Tolling Study (20 minutes)[19-158](#)**Andy Henry, LPA Staff****Lynn Purnell, WSP**

The Triangle Strategic Tolling Study is to identify potential toll projects for inclusion in the update of the MPO's Metropolitan Transportation Plan (MTP) and to begin a dialog around the issues of tolling. The Study most recently produced performance measures and cost estimates for the travel corridors that demonstrated the most potential for toll facilities. The Study consultant, WSP, will present the performance measures and costs, discuss next steps, and answer Board member questions. A copy of the presentation is attached.

8. Amendment to the Orange County Transit Plan (5 mins)[19-161](#)**Meg Scully, LPA Staff****Aaron Cain, LPA Staff**

The 2017 Orange County Transit Plan allocates \$6.1 million to the Chapel Hill North-South Bus Rapid Transit (NSBRT) Project. Chapel Hill Transit has requested an additional \$8 million in dedicated transit revenue be allocated to the project through an amendment to the 2017 Plan. This amendment is intended to provide the Town of Chapel Hill with evidence that fifty percent of the non-federal match is dedicated to the project through the Transit Plan. The DCHC MPO Board is one of three parties to the Orange County Transit Plan. The other two, including the Boards of the Orange County Commissioners and of GoTriangle, have already approved the amendment.

TC Action: Recommend the Board approve and sign the amendment to the Orange County Transit Plan.
