ACTION ITEMS

5. <u>Approval of Amendment #11 to the FY2016-25 Transportation</u> <u>Improvement Plan (10 minutes)</u> Aaron Cain, LPA Staff

NCDOT pushed back the concurrency and effectiveness date for the upcoming FY2018-27 TIP from October 1, 2017 to January 1, 2018. The result of this delay is that projects will not be able to access FY18 STBGDA or CMAQ funds during the interim period. In order to allow projects that are ready to access those funds, an amendment to the current FY2016-25 is required.

Three DCHC MPO projects meet this description:

- C-5650, South Greensboro Street Sidewalk in Carrboro (this is a new TIP number due to the inclusion of CMAQ funds, previously U-4726Dx);

- U-5543, Variable Message Signs in Chapel Hill; and
- U-5549, Churton Street Improvements in Hillsborough.

This amendment will allow these projects to access FY18 STBGDA and FY18 CMAQ funds in early October. A summary list and full report of the changes are included as attachments along with a resolution to be signed by the MPO Board Chair upon approval by the Board.

TC Action: Recommend the Board approve Amendment #11 to the FY2016-25 Transportation Improvement Plan.

6. <u>SPOT P5.0 Project Recommendations (25 minutes)</u> Aaron Cain, LPA Staff

Under North Carolina's Strategic Transportation Investments (STI) program, transportation revenues are allocated based on data-driven scoring and local input. The DCHC MPO is currently determining which projects will be submitted for scoring into SPOT 5.0. DCHC's projects will be rated along with projects from across the state to determine which will be funded in the FY2020-29 Transportation Improvement Plan (TIP).

DCHC may submit up to 23 projects per mode for SPOT 5.0 consideration. DCHC also gets an additional highway submittal because a project was dropped from the FY 2019-27 TIP. LPA staff has been working with a subcommittee of local government staff to determine the 24 highway and 23 bicycle/pedestrian projects that will be submitted for DCHC. In addition, 21 transit and 10 rail projects have been identified for entry in SPOT 5.0. The TC is asked to review and discuss the recommendation from the subcommittee and recommend the projects from each mode to the DCHC MPO Board for approval at its September 13 meeting. New project submissions must be entered into SPOT 5.0 by September 29.

TC Action: Review and discuss the recommendation from the subcommittee for the top priority highway, bicycle/pedestrian, transit, and rail project submittals and make a recommendation to the DCHC MPO Board for approval and submission to SPOT 5.0.

7. <u>2045 Metropolitan Transportation Plan (MTP) -- Alternatives Analysis</u> (15 minutes) Andre Honge -- DA Staff

Andy Henry, LPA Staff

LPA staff will provide an update on the Alternatives Analysis and discuss steps in the development of the Preferred Option (or, the draft 2045 MTP).

The Board released the Alternatives Analysis for public input at their August meeting and will conduct a public hearing at their September meeting. The metrics and maps are available on the MPO's Alternatives Analysis Web page:

www.bit.ly/DCHC-MTP-Alternatives. The draft public input plan for the Alternatives Analysis is attached. The LPA staff will continue to work with local staff to develop presentation materials for the public input events.

The next step in the MTP process is to develop the Preferred Option. The LPA staff will work with local staff to identify the projects that should be in the Preferred Option, and then likely conduct a sub-committee meeting to discuss the budget and project selection in the first few weeks of September (in time to include the materials in the September Technical Committee meeting).

The schedule for the 2045 MTP is as a follows:

- * Deficiency Analysis; Board released in June
- * Alternatives Analysis, Board released in August
- * Preferred Option, Board to release in October
- * Adopted 2045 MTP, Board to adopt in <u>December</u>.

TC Action: Provide comments on the Alternative Analysis and Preferre Option process, and recommend that the Board conduct a public hearing on the Alternatives Analysis at their September meeting.

8. <u>Review of NCDOT Bicycle and Pedestrian Policy (10 minutes)</u> Aaron Cain, LPA Staff

In late June, DCHC MPO staff learned that the N.C. Board of Transportation is considering changes to the NCDOT Sidewalk and Pedestrian Policy. It is not clear what role MPOs and RPOs will have in the review of the policy. LPA staff recommend that over the next few weeks the members of the Technical Committee review the existing Sidewalk and Pedestrian Policy and provide comments and suggestions for change, which will be reviewed at the September Technical Committee meeting and provided to the MPO Board for consideration. A subcommittee meeting may be convened if necessary.

TC Action: Solicit and compile comments on the Sidewalk and Pedestrian Policy for review by the Technical Committee at its September meeting.

74	Terry Bellamy shared the overarching vision, core principles, and a brief history of the Vision
75	Zero program. He also shared crash data for Durham County and discussed the strategies of the Vision
76	Zero Durham program. Terry Bellamy reviewed the upcoming schedule of Vision Zero Durham events
77	and led TC meeting attendees in taking the Vision Zero Durham pledge.

100	DCHC MPO is required by federal regulations to prepare an annual UPWP that details and guides
101	the urban area transportation planning activities. On February 8, 2017, the DCHC MPO Board approved
102	the FY18 UPWP with a period of performance from July 1, 2017, to June 30, 2018. Meg Scully called
103	attention to the August 25, 2017, deadline for processing the first amendment, and the grant reporting
104	due date table in the agenda packet.
105	This item was informational and no further action was required by the TC.
106 107	8. FFY17 Section 5307/5340 FULL Apportionment Split Letter (5 minutes) Meg Scully, LPA Staff
108	Section 5307/5340 funds are allocated to urbanized areas for transit capital and operating
109	assistance, and for transportation planning. The MPO's full apportionment for FFY17 for each program
110	was released by Federal Transit Administration (FTA) and the Lead Planning Agency (LPA) Staff, in
111	consultation with the four fixed-route transit operators, developed a recommended distribution of this
112	funding. A split letter to FTA regarding the allocation of these funds among transit operators must be
113	approved by the MPO Board to authorize transit operators to seek applications for funding.
114	Bergen Watterson made a motion to recommend that the MPO Board approve the distribution
115	and endorse the attached FFY17 full apportionment split letter. John Hodges-Copple seconded the
116	motion. The motion passed unanimously.
117	Meg Scully reminded the TC about the training for sub-recipients of UPWP planning funds that
118	was scheduled after the TC meeting.
119 120	<u>9. FY2018-27 TIP Update</u> Aaron Cain, LPA Staff
121	Aaron Cain drew attention to an attachment showing the list of DCHC MPO projects that made it
122	into the recently released State Transportation Improvement Program (STIP), and that will therefore be
123	incorporated into the Transportation Improvement Program (TIP). He briefly discussed the schedule for

124 developing the TIP, and the required public comment periods and public hearings. Aaron Cain discussed

125	NCDOT's recommendation that three projects, the grade separation at Blackwell Street/Mangum Street
126	and two managed lane projects on I-40, be removed from consideration in Strategic Prioritization Office
127	of Transportation (SPOT) 5.0. Aaron Cain stated that Congestion Mitigation/Air Quality Improvement
128	Program (CMAQ) awards were recently released, and that the MPO received funding for all of its
129	requested projects. He added that a couple of TIP numbers may be changing.
130	There was discussion of whether the I-40 managed lanes projects could be removed from the
131	TIP while staying in the STIP.
132	Aaron Cain and Chair Ellen Beckmann discussed draft municipal agreements for CMAQ projects.
133	In response to a question from John Hodges-Copple, Aaron Cain clarified that the
134	Blackwell/Mangum project is a rail project. There was discussion of how rail projects are funded, and
135	how funding would be reallocated if the Blackwell/Mangum project is removed from the STIP. Chair
136	Ellen Beckmann inquired whether the TC action needed to be modified to reflect that the recommended
137	MPO Board action was removing the three projects from the TIP, not the STIP, and that the draft TIP
138	should be released for public comment by August 23, 2017. There was discussion of whether there was
139	any advantage to removing the three projects from the TIP immediately, or waiting for SPOT 5.0 scoring.
140	Chair Ellen Beckmann, John Hodges-Copple, and Geoff Green discussed whether removing the
141	Blackwell/Mangum project from the TIP, and not the STIP, would be a problem for GoTriangle. John
142	Hodges-Copple and Geoff Green discussed how the Blackwell/Mangum project would be rescored in
143	SPOT 5.0.
144	Geoff Green made a motion to recommend to the MPO Board that projects I-5702A, I-5702B,
145	and P-5710 be removed from the STIP, and that the MPO Board release the draft TIP for public comment
146	on or by August 23, 2017. Vice Chair Margaret Hauth seconded the motion. The motion passed

147 unanimously.

148 **10. SPOT 5.0 Update**

149 Aaron Cain, LPA Staff

150	Aaron Cain discussed the overlap between the TIP and SPOT schedules, and stated that he
151	would notify the SPOT office that the three projects discussed in the previous agenda item would not be
152	resubmitted for prioritization in SPOT 5.0. Aaron Cain drew attention to handouts detailing the
153	proposed modifications and deletions for SPOT 5.0. He noted that the Divisions, along with any MPOs
154	and Rural Planning Organization (RPOs) in which a project is situated must concur with any
155	modifications and deletions from SPOT 5.0 for Carryover projects. Aaron Cain noted that Division 5 has
156	already agreed to the modification of a couple of developmental projects, and that he needed to make a
157	correction to the U-5720C project to reflect that only part of that project would be removed and that a
158	multi-use path would be added to the project. Aaron Cain reviewed modifications that would be made
159	to several projects. He noted that projects that were moved in the most recent STIP from
160	developmental to committed cannot be modified through the SPOT process, but that these projects
161	could be modified through other avenues.
162	Aaron Cain suggested that Transportation Secretary James Trogdon's request to the Divisions to
163	investigate alternative scoring criteria for the SPOT process should be discussed. Aaron Cain stated that
164	Divisions 5, 7, and 8 developed a framework for alternate criteria. Aaron Cain discussed these
165	alternative criteria, especially how freight scores and safety would be taken into consideration, and how
166	such alternative criteria might affect the DCHC MPO.
167	Aaron Cain reviewed NCDOT's definition of accessibility and connectivity in response to an
168	inquiry from Vice Chair Margaret Hauth.
169	There was discussion of whether there was any data on freight on NC 751, and whether freight
170	data is only available for interstates and US routes.
171	Geoff Green and Pat Wilson discussed NCDOT's decision not to concur with the changes to
172	various projects along US 15-501 to change them away from capacity improvements.

Aaron Cain clarified that this year, unlike in previous years, the MPO Board has to vote not to use alternate criteria and stick with the default criteria.

Chair Ellen Beckmann and Terry Bellamy discussed the fact that congestion outweighs safety in 175 176 Region C. Aaron Cain stated that several other MPOs would have to agree to changes regarding safety 177 versus congestion in Region C, and that freight was considered more of a priority than safety in a recent 178 meeting with other members from Region C. There was continued discussion of the decisions of various 179 Regions regarding freight and the boundaries of various regions. 180 Aaron Cain pointed out that the MPO Board already approved the modifications and deletions 181 subject to future changes after discussion with the Divisions, and that they may not need to endorse the 182 most recent changes. Aaron Cain promised to follow up with the Capital Area Metropolitan Planning Organization 183 184 about changes to project U-5518. 185 Cara Coppola made a motion to recommend that the MPO Board endorse the proposed alternate criteria for highway projects in SPOT 5.0. Laura Woods seconded the motion. The motion 186 187 passed unanimously. 11. 2045 Metropolitan Transportation Plan (MTP) – Alternatives Analysis 188 Andy Henry, LPA Staff 189 190 Andy Henry discussed the schedule for developing and adopting the 2045 MTP, and drew 191 attention to deadlines that the MPO needs to meet in order to avoid triggering new requirements or a 192 plan lapse. Andy Henry stated that the Alternatives Analysis was an opportunity for staff, the public and the MPO Board to begin talking about solutions to different deficiencies, and how different aspects of 193 194 the Alternatives Analyses will be used to create the final MTP. Andy Henry differentiated the four

195 Alternative Analysis scenarios from each other, and discussed the methodology that was used to create

- 196 the scenarios. He also discussed the performance measures, such as travel isochrones, that will be used
- 197 to evaluate the scenarios. Andy Henry also reviewed the color key on the congestion maps, and

discussed the comparison of Traffic Analysis Zones (TAZs) near the proposed light rail and other high-

199 end transit to the overall region.

200 Andy Henry and Chair Ellen Beckmann discussed the kinds of trips that were used in the 201 scenarios.

Andy Henry discussed the travel time index and the methodology he used to calculate the cost of congestion. Andy Henry clarified that data for other corridors is available, and the only restriction on corridors is that they need to be within the modeling area/DCHC MPO boundary. There was discussion

of the University of North Carolina at Chapel Hill employment data that was used for the scenarios.

206 Chair Ellen Beckmann and Andy Henry discussed whether the highway and transit networks

207 have been informed by fiscal constraint. The Alternatives are not fiscally-constrained. Andy Henry

discussed how the fact that SPOT funding is divided into statewide, regional, and division funding affects

the projects in the MTP.

210 Craig Benedict and Andy Henry discussed why the Volume to Capacity (V/C) analysis of US 15-

211 501 shows a free flow of traffic.

212 Craig Benedict made a motion to forward the Alternatives Analysis to the MPO Board based on

213 input from the TC subcommittee, and recommend that the MPO Board release the Alternatives Analysis

for a 42-day public comment period. Cara Coppola seconded the motion. The motion passed

215 unanimously.

216 **12. New Position for Transit Planning Services for DCHC MPO**

217 Felix Nwoko, LPA Staff

The Durham and Orange County Transit Plans, adopted in April 2017, include an expectation that each county would create a Staff Working Group (SWG) to develop Annual Transit Work Plans and review quarterly progress reports on the Durham-Orange Light Rail Transit and other transit projects and services. Furthermore, the plans envision and fund an administrator to provide services to support the SWGs. Subsequent discussions between DCHC MPO, GoTriangle, and Triangle J Council of

223	Governments (TJCOG) have determined that a position should be housed within the DCHC MPO to serve
224	these functions. The position would also perform transit planning and other duties for the DCHC MPO in
225	addition to serving the SWGs.

226 Geoff Green pointed out that the planner would not be creating the annual work plans, but coordinating their creation. Felix Nwoko confirmed that this was the case and that this would be 227 228 reflected in the job description when the job is advertised. Craig Benedict noted that in some instances, 229 the description of the position indicates that the planner would serve SWGs (plural), while in others it 230 states that the position would serve a SWG (singular). He asked that the language in the description for the position be made consistent. Chair Ellen Beckmann and Felix Nwoko discussed how the positon 231 232 would be funded. Felix Nwoko confirmed that the position was a permanent one in response to an inquiry from Cara Coppola. Craig Benedict suggested that there should be some discussion of how the 233 234 position would be evaluated given that it is a joint position. 235 Kumar Neppalli made a motion to recommend to the MPO Board that the position of transit planner to support the recently adopted Durham and Orange County Transit Plans be approved. Vice 236 237 Chair Margaret Hauth seconded the motion. The motion passed unanimously. 238 **REPORTS:** 239 13. Reports from the LPA Staff Felix Nwoko, LPA Staff 240 241 Felix Nwoko provided updates on the US 15-50 and the NC 54 West corridor studies. He also 242 noted that the Intelligent Transportation Systems project would be kicking off shortly.

In response to a question from Laura Woods, Chair Ellen Beckmann confirmed that there is room for the roundabout and that no structures would be impacted by the roundabout.

Richard Hancock, NCDOT Division 5, provided details for a public meeting that would be held to discuss newly proposed roadway closures related to the East End Connector project. Chair Ellen Beckmann and Richard Hancock discussed the proposed length of the closures. Richard Hancock also discussed upcoming closures on Angier Avenue and NC 147. He also stated that the pouring of the deck of the new bridge over NC 147 at Alston Avenue was about to occur and that traffic would be moved over to the bridge shortly. Brian Kluchar confirmed that the 270 New Hope Church Road project does not extend to the Wake County line in response to a question from 271 Cara Coppola.
