9. <u>Amendment to the Orange County Transit Plan (5 mins)</u> Meg Scully, LPA Staff Aaron Cain, LPA Staff

Durham County Transit Plan Update (10 mins)

Pat Young, Durham City-County Planning Department

The 2017 Orange County Transit Plan allocates \$6.1 million to the Chapel Hill North-South Bus Rapid Transit (NSBRT) Project. Chapel Hill Transit has requested an additional \$8 million in dedicated transit revenue be allocated to the project through an amendment to the 2017 Plan. This amendment is intended to provide the Town of Chapel Hill with evidence that fifty percent of the non-federal match is dedicated to the project through the Transit Plan. The DCHC MPO Board is one of three parties to the Orange County Transit Plan. The other two, including the Boards of the Orange County Commissioners and of GoTriangle, have already approved the amendment.

10. <u>Triangle Strategic Tolling Study - Final Report (20 minutes)</u> Andy Henry, LPA Staff

The final report of the Triangle Strategic Tolling Study explores toll and express lanes for the region, identifies potential toll projects for inclusion in long-range plans and creates a framework for the MPO to discuss and evaluate toll projects. The final report is a compilation of the deliverables that have occurred as the project progressed. However, there is some additional material related to the issue of equity that will be of interest to the DCHC MPO. Section 4.5 "Equity Considerations" (page 34) identifies potential impacts on specific income, modal and geographic communities, and identifies managed lane projects in the U.S. that have implemented policies to mitigate the impacts. The Executive Summary has an equity section and the Tier 2 corridor evaluation measures impacts on low-income residents (page 50).

Staff and the consultant, WSP, have provided several presentations to the MPO Board as the project has progressed over the last two years. Most recently, the MPO Board received a presentation at the May 29th joint MPO Board meeting and the MPO's June Board meeting.

The MPO's Public Involvement Policy does not specify a minimum public comment period for studies. However, MPO practice has been to have a 30-day minimum comment period, conduct a public hearing at the Board meeting that follows the release, and approve at the Board meeting that follows the hearing. As such, staff recommends the following public input schedule for the Tolling Study:

- · Board release final report August 14
- Public comment period, August 14 through September 10
- · Board conduct public hearing September 11
- Board approve final report October 9

11. <u>Amendment #14 to the FY2018-2027 TIP (5 minutes)</u> Aaron Cain, LPA Staff

TIP Amendment #14 moves funding for three City of Durham CMAQ projects. FY19 funds from C-5605H, Downtown Durham Wayfinding, would be moved to C-5605E, Durham Bike Lanes, and C-5605I, Durham Bike Boulevards. The purpose for this movement of funds is cost overruns on all projects and the uncertainty that C-5605H will be able to obligate its funds by the September 30, 2019 rescission deadline. Additional funds would be programmed to C-5605H in FY20.

The programming of FY20 CMAQ funds to C-5605H will essentially exhaust the FY20 & FY21 DCHC CMAQ distribution, presuming the MPO wishes to continue funding the TJCOG Transit Demand Management (TDM) program. An attachment shows previously approved programming of FY20-21 DCHC CMAQ funds, including the proposed funds for C-5605H. Should this amendment be approved, no CMAQ funds would be available for new projects in FY20-21, nor would there be additional funding for currently programmed projects.

Also included in this TIP amendment are adjustments to schedules for GoTriangle bus purchases and several City of Durham bike/ped projects, as well as additional funding for several statewide projects.

The summary sheet, full report, and resolution are attached.

12. <u>SPOT 6 Update (10 minutes)</u> Aaron Cain, LPA Staff

On July 25, 2019, MPO staff received the attached communication from NCDOT providing notification that the SPOT 6 process will be delayed and work towards the creation of a FY2023-2032 STIP, rather than the previously planned FY2022-2031. At this time, MPO staff does not have specific information on the timing of the various phases of the SPOT process. Staff will provide as much information as possible at the Board meeting.

Also attached is the updated project submittal list for SPOT 6. While no comments have been received by staff from Board members since the last Board meeting, there have been some adjustments based on conversations with local staff and the Research Triangle Foundation. An updated project submittal list is attached.

102	10. Update on the DCHC MPO Federal Certification Review

103 Meg Scully, LPA Staff

104	Meg Scully stated that The Federal Highway Administration (FHWA) and Federal Transit
105	Administration (FTA) are required to jointly review the Metropolitan Transportation Planning process
106	for the DCHC MPO at least every four years. Meg Scully stated that quadrennial review is to ensure
107	that the DCHC MPO is following federal policies, regulations, and procedures in developing the
108	transportation planning process. Meg Scully added that federal agencies conducted the DCHC MPO
109	on-site review on May 20, 2019, and will present their official report to the MPO Board later this
110	year, however, federal officials made mention that they are pleased with the quality and quantity of
111	our work product and DCHC MPO passed the Federal Certification Review process. Renee Price and
112	Meg Scully discussed that the federal officials were pleased with the amount of public involvement,
113	however, there were no public participation during the review process, which was not atypical.

115	11. Triangle Strategic Tolling Study
116	Andy Henry, LPA Staff

117 Lynn Purnell, WSP

118 Lynn Purnell stated that the purpose of the Triangle Strategic Tolling Study was to evaluate 119 the regional transportation network and to examine if toll lanes would benefit the Triangle region. 120 Lynn Purnell discussed that the Tolling Study included meeting with regional partners and 121 stakeholders. Lynn Purnell explained the difference between toll roads and express toll lanes. Lynn 122 Purnell stated the Tolling Study used the Triangle Regional Model and used projected 2045 vehicle 123 volumes, and the Tolling Study also focused on evening peak hours. Lynn Purnell discussed future 124 meetings with regional transportation partners. Lynn Purnell also stated that a subcontractor was 125 used for toll modeling for the Tolling Study. Lynn Purnell discussed that the seven factors 126 investigated were; projected revenue, travel time savings, trip dependability, transit supportiveness, 127 the number of transit routes, access to jobs, and economic justice.

Ellen Reckhow and Lynn Purnell discussed the methodology used in examining economic 128 129 impact. Lynn Purnell added that only work trips were used in assessing economic justice impact. Michael Parker and Lynn Purnell also discussed what alternatives there might be for residents who 130 131 cannot afford tolling costs. Vice Chair Wendy Jacobs asked what other regions were doing to address 132 equity. Lynn Purnell responded that the information will be in the Tolling Study report. 133 Lynn Purnell stated that there are three corridors within the DCHC MPO region: I-40 between NC 54 and NC 147; US 70; and NC 147. Michael Parker and Lynn Purnell discussed the efficacy of 134 tolling and transit with respect to lowering travel times. North Carolina Board of Transportation 135 (NCBOT) Chairman Mike Fox commented that the DCHC MPO will be able to evaluate each project 136 137 within each corridor on its own merits. Lynn Pernell added that many urban areas regard tolling as a congestion management tool. NCBOT Mike Fox added that toll lanes are often a means to provide 138 139 funding to projects in a more expedited manner. 140 Jenn Weaver and Lynn Purnell discussed that tolling lanes would be added to any existing corridors, and lanes would not be removed. Pam Hemminger asked if there was evidence that van 141 142 pooling increased as a result of adding tolling. Lynn Purnell responded that there was no evidence of 143 such an increase, however, many express lanes were at one time High Occupancy Vehicle (HOV) 144 lanes. Lydia Lavelle asked if adding additional lanes would displace residents. Lynn Purnell responded 145 that it would depend on the specific corridor. Lynn Purnell and Vice Chair Wendy Jacobs discussed 146 the reasoning of corridors using the constrained model. Lynn Purnell and Vice Chair Wendy Jacobs 147 further discussed the safety issues and geometric concerns as they relate to the constrained model. 148 Andy Henry stated that there are one-page fact sheets on all of the ten corridors in the Tolling Study 149 on the MPO webpage.

151 **12. Discussion of Joint Board Meeting**

152 Damon Seils, Chair

Chair Damon Seils thanked NCBOT Chairman Mike Fox and all DCHC MPO Board Members 153 154 who were able to attend the Joint MPO Board Meeting. Chair Damon Seils and NCBOT Chairman Mike Fox discussed the importance of regional partnerships for transportation improvements in the 155 156 Triangle area. NCBOT Chairman Mike Fox highlighted three issues that were discussed at the Joint 157 Meeting: federal rescission of Transportation Alternative Program Direct Attributable (TAPDA) and 158 Congestion Mitigation and Air Quality (CMAQ) funds; the North-South Bus Rapid Transit (NS BRT); 159 and the Triangle Trails Initiative and the Triangle Bikeway. Ellen Reckhow and NCBOT Chairman Mike 160 Fox discussed Sign Hutchinson's involvement in both bike-ped projects. No action is necessary at this time. This item is for informational purposes only. 161 162 13. Update on Potential Rescission of CMAQ and TAP-DA Funds 163 Aaron Cain, LPA Staff 164 Aaron Cain stated that the two primary sources of funding that are eligible for federal rescission are TAPDA and CMAQ funding, which total approximately \$75,000 in unobligated funds. 165 Aaron Cain added that there is a narrow process for authorizing TAPDA through federal legislation, 166 therefore, projects that are already have TAPDA funding are more desirable for reprogramming of 167

168 TAPDA funds. Aaron Cain continued that the Morgan Creek Greenway project is eligible for TAPDA 169 and has already begun the bidding process. Aaron Cain stated that there are four projects for CMAQ 170 funding that MPO staff and local jurisdictions are working together to have funding obligated by the

171 September 30 deadline.

There was discussion about the process of rescission. Aaron Cain and Chair Damon Seils discussed that the funding for eligible projects will not disappear, however, funding in subsequent Fiscal Years may diminish as a result. Vice Chair Wendy Jacobs and NCBOT Chairman Mike Fox discussed the need for communication with NCDOT Division staff will be necessary for further clarification of rules and regulations. Ellen Beckmann noted that NCDOT reviews of CMAQ funding projects sometimes get lower review scores for removing car lanes while adding Bike-Ped options.

Aaron Cain stated that projects are currently being considered for inclusion in the SPOT 6 submittal
 list by MPO staff.

There was discussion about NCDOT putting on hold indefinitely a number of projects due to 180 181 insufficient funding in the North Carolina Transportation reserve fund. NCBOT Chairman Mike Fox 182 explained that, due to unforeseen events such as two hurricanes and settlement from MAP Act 183 litigation, the relatively low balance in the North Carolina State reserve fund is has prevented new 184 projects to be funding until the situation is resolved. NCBOT Chairman Mike Fox continued that there 185 are currently plans to increase the reserve funding. Nina Schlosberg-Landis stated that a final decision about what projects will and will not be funded has not yet been concluded. NCBOT 186 187 Chairman Mike Fox added that if a project is let and under construction then it will proceed as planned. Chair Damon Seils stated he will send information regarding the Estes Drive Extension 188 189 North Greensboro Street Roundabout project in Carrboro, which has been put on hold, to Aaron Cain 190 and Felix Nwoko.

191 No action is necessary at this time. This item is for informational purposes only.

192 14. SPOT 6 Update and Initial Project List Review

193 Aaron Cain, LPA Staff

Aaron Cain stated that the funding that goes through the SPOT process is divided as follows:
40% for Statewide Mobility projects; 30% for Regional Impact Projects; and 30% for Division Needs
projects. There was discussion about how projects are classified in these three areas. Aaron Cain
added the DCHC MPO is comprised of three Divisions: 5, 7 and 8; and three Regions; C, D and E.
Aaron Cain described the differences between Regional and Division projects.
Aaron Cain described the proposed rules changes from North Carolina Board of

200 Transportation. Aaron Cain described that one of the proposed changes would be to increase the

201 window for committed projects from five to six years. Aaron Cain stated that more projects would be

202 committed, but less funding will be available for distribution for new projects. Aaron Cain added that

another proposed change would be the ability to flex up to 500 points between Regional and Division
 projects, which each receive 1,800 points. Aaron Cain added that there are no proposed changes to
 the transit funding or the rail funding formulas.

Aaron Cain and Ellen Reckhow discussed the most efficient ways to increase bicycle safety on

206

rural roads would be to submit projects as modernization projects to increase the shoulder width. 207 208 Aaron Cain stated that another proposed change would be to have competition for non-highway 209 projects solely within the Division at the Division Needs level. There was discussion about funding 210 projects in urban versus rural areas. NCBOT Chairman Mike Fox discussed that historically rural areas did not receive an equal apportionment of funding as more urban areas. Nina Szlosberg-Landis 211 212 suggested that Board Members send her and NCBOT Chairman Mike Fox concerns and questions. 213 Nina Szlosberg-Landis proposed that the DCHC MPO begin a policy change for a larger 214 apportionment of non-highway funding. Chair Damon Seils and Nina-Szlosberg Landis discussed 215 contacting other MPOs with similar interests for support. Aaron Cain stated that the SPOT submittals are now due in December 2019 instead of 216 217 September. Aaron Cain asked that DCHC Board Members review the proposed project submittal list 218 and provide comments as well as additional requested projects. Chair Damon Seils and Aaron Cain 219 discussed that DCHC MPO Board Members also consult their staff from their respective local 220 jurisdictions. Vice Chair Wendy Jacobs asked how the discontinuation of the D-O LRT will impact the 221 proposed project list. Aaron Cain responded that there are several transit projects that are placeholders, which will be discussed the NCDOT staff in the upcoming months. Aaron Cain added 222 223 that the local Divisions also have several available submittal slots that were offered to DCHC MPO. Aaron Cain stated that the next round of discussion will occur for the SPOT 6 submittal list at an 224 225 upcoming MPO Board meeting.

- Vice Chair Wendy Jacobs and Aaron Cain discussed that a formal conversation by MPO staff
 to create policy for multiuse path preference. There was further discussion about the naming of
 multiuse paths.

- 230 15. Resolution to Request Delay to U-5774 (NC 54)

231 Aaron Cain, LPA Staff

232 Aaron Cain stated that Staff from NCDOT, DCHC MPO, the Town of Chapel Hill, the City of 233 Durham, and GoTriangle met to discuss the possibility of including high capacity transit options in the NC 54 corridor from Fordham Boulevard in Chapel Hill to I-40 in Durham due to the discontinuation 234 235 of the Durham-Orange Light Rail Transit (D-O LRT) project. State Transportation Improvement Plan 236 (STIP) project U-5774 (sections B, C, and F) will provide improvements to NC 54 in this corridor and is 237 currently in the conceptual design and National Environmental Policy Act (NEPA) phases. It may be possible to design high capacity transit options in this corridor and have the construction of those 238 239 improvements coincide with the planned road improvements. In order to investigate this option, NCDOT Division 5 asked for a formal request from the DCHC MPO Board to delay U-5774. 240 241 MPO Staff will work with staff from GoTriangle, Chapel Hill Transit, GoDurham, NCDOT, the University of North Carolina at Chapel Hill, and others to identify possible high capacity transit 242 options in this corridor with the goal of submitting at least one transit project for this corridor to 243 244 SPOT 6. Project concepts will need to be devised by the end of October in order to be released for 245 public comment with the list of all projects from DCHC MPO for SPOT 6. 246 Ellen Reckhow made a motion to approve the resolution requesting a delay for U-5774. Michael Parker seconded the motion. The motion passed unanimously. 247

 16. Amendment #13 to the FY2018-2027 TIP

249 Aaron Cain, LPA Staff

250	Aaron Cain stated that Amendment #13 to the FY2018-2027 Transportation Improvement Plan
251	(TIP) consists of a request from the City of Durham to add funding to four bike-ped projects: Aaron Cain
252	added that two of the projects cost over \$1M, and per MPO policy, the projects were required to enter a
253	21-day public policy period. Aaron Cain added that the Amendment #13 was released for a 21-day public
254	comment period on May 15, 2019. No public comments were received.
255	Ellen Reckhow made a motion to approve Amendment #13 to the FY2018-2027 TIP. Charlie
256	Reece seconded the motion. The motion passed unanimously.
257 258 259	<u>16a. Chapel Hill North South Bus Rapid Transit Project</u> Aaron Cain, LPA Staff Matt Cecil, Chapel Hill Transit
260	Aaron Cain stated that Chapel Hill Transit is requesting \$8M for the NS BRT in addition to the
261	\$6.1M already in the Transit Plan, which is considered a material change, therefore it must be adopted
262	by the Board of County Commissioners, the GoTriangle Board of Trustees, and the DCHC MPO. Aaron
263	Cain. Matt Cecil stated that Chapel Hill Transit received guidance from the FTA to apply for a rating from
264	the Small Starts Program by September 1, 2019, in order to demonstrate that 50% of the local funding
265	match has been obtained. Matt Cecil continued that the NS BRT is planned to be submitted in SPOT 6,
266	however, that will not meet the Small Starts deadline. Aaron Cain added that if the SPOT 6 funding is
267	successful, then the full \$14M would not be needed.
268	There was no action required. This item will return to the DCHC MPO Board at their meeting on
269	August 14, 2019.

11	The Durham-Chapel Hill-Carrboro Metropolitan Planning Organization Board met on May 29, 2019,
12 13	at 9:00 a.m. at the Research Triangle Park Headquarters committee room.
13	Sig Hutchinson and Damon Seils welcomed everyone to the Joint DCHC MPO and CAMPO
15	Meeting. Members, Alternates, and partners of the DCHC MPO and CAMPO made introductions as
16	they went around the table.
17	2. Host Welcome
18	RTP Host Welcome
19	Scott Levitan, Research Triangle Foundation
20	Scott Levitan stated that Durham County recommitted to a \$20M infrastructure grant to
21	support the Research Triangle Park (RTP) Hub project. Scott Levitan stated that we have untapped
22	taxing authority that can be applied to mobility projects, and CAMPO will be an important partner with
23	companies in order to support Bus Rapid Transit (BRT) in the Triangle region. Scott Levitan also stated
24	that GoTriangle has negotiated a contracted with Uber and Lyft to provide intra-park service within
25	RTP. Scott Levitan promoted Box Yard and the Frontier.
26	3. Comments From the Public
27	Ed Harrison discussed how transportation has changed over the past few decades in the Triangle
28	Region. Ed Harrison stated that transit options, especially BRT, are a very important form of
29	transportation within the Triangle region.
30	4. Transit Investment Discussion

31 Fixed Guideway Investment Updates

32 i. Wake County BRT

33 Mila Vega, City of Raleigh

Mila Vega presented information pertaining to the Bus Rapid Transit (BRT) portion of the Wake 34 35 County Transit Plan, which will be effective until 2027. Mila Vega stated that are three main categories for projects; bus service expansion, Commuter Rail Transit (CRT), and BRT. Mila Vega continued that 36 37 there are four main projects under consideration along north, east, west, and south corridors. Mila Vega 38 stated that a Major Investment Study (MIS) was conducted. Mila Vega stated that a Small Starts Project 39 Development (PD) application was submitted for the eastern BRT portion, and is awaiting a response 40 from the Federal Transportation Administration (FTA), which will likely occur in June 2019. Mila Vega 41 also stated that a September Strategic Planning Office of Transportation (SPOT) 6 rating application is being prepared. Mila Vega also stated a Transit Signal Priority (TSP) grant for the BRT was received. Mila 42 43 Vega stated that the Small Starts Grant was applied for using a 49/51 split, of which the latter percentage would be local funding. Mila Vega stated that there will be a public meeting on June 6 at the 44 Convention Center and a BRT open house on June 25 from 4-7 p.m. at the Market Street Baptist Church. 45 Mila Vega and Wendy Jacobs discussed the structure of public involvement meetings. Mila Vega 46 stated that additional BRT information can be found at Raleigh.gov/brt. North Carolina Board of 47 48 Transportation (NCBOT) Chairman Mike Fox, Mila Vega, and David Eagman discussed the possibility of 49 having an alternative plan if the BRT proposal does not receive federal funding.

50 ii. Chapel Hill BRT

51 Matt Cecil, Town of Chapel Hill

52 Matt Cecil presented information regarding the North-South Bus Rapid Transit (NS BRT) in 53 Chapel Hill. Matt Cecil stated that an 8.2 mile corridor is being proposed to run along the 'spine' of 54 Chapel Hill that is scalable and can be built upon in future years. Matt Cecil described the current bus 55 transit system within Chapel Hill. Matt Cecil described the process of partner involvement for the NS

BRT. Matt Cecil stated that the NS BRT is part of the Small Starts program administered by the FTA. Matt 56 57 Cecil described that the NS BRT would travel within Chapel Hill, including lane designations. Matt Cecil added that a multiuse path is proposed along both sides of the NS BRT corridor. Matt Cecil stated that 58 59 the 30% designs are scheduled to be completed by late summer 2019. Matt Cecil continued that the NS 60 BRT is scheduled by be rated by the FTA in September 2019. Matt Cecil stated that NS BRT is scheduled 61 to be open for revenue service in 2023. Matt Cecil stated that \$6.1M of the non-federal funds have been committed through the Orange County Transit Plan, but \$8M in additional funding is being requested. 62 Matt Cecil continued that \$25M of funding is being requested through the SPOT 6.0 process as well. 63 Matt Cecil added that the funding model consists of an 80/20 split with the federal government, 64 indicating that the federal government would provide \$112M of funding for the NS BRT. 65

66 <u>iii. NCRR Corridor Passenger Rail</u> 67 Jeff Mann, GoTriangle

68 Jeff Mann presented information on the planning process for the Commuter Rail Transit (CRT) 69 along the North Carolina Railroad (NCRR) corridor that would connect Raleigh to Durham. Jeff Mann stated that the CRT project is planned to go into Project Development (PD) by the end of 2019. Jeff 70 71 Mann stated that the MIS has engaged regional partners and stakeholders. Jeff Mann added that a 72 kickoff meeting occurred on May 10. Jeff Mann discussed the location of CRT stations and the frequency 73 of service. Jeff Mann stated that part of the MIS was to investigate extending service to Johnston, 74 Orange, and Alamance counties. Jeff Mann stated that the Triangle Regional model was a tool in order 75 to calculate ridership and revenue. Jeff Mann stated that the MIS also evaluated capital improvements 76 so that Amtrak and Norfolk Southern routes and services would not be impeded, and that a capital cost 77 estimate is currently being updated. Jeff Mann and NCBOT Chairman Mike fox discussed that the anticipated organization that would run the CRT would be GoTriangle. Jeff Mann and Damon Seils 78 79 discussed the importance of cooperation and agreement with key regional stakeholders and partners in 80 a timely manner.

81 County Transit Plans Discussion

82 <u>i. Wake Transit Vision Plan (Wake County Transit Plan)</u> 83 Brett Martin, CAMPO

84 Brett Martin stated that the Wake County Transit Plan was adopted by CAMPO, Wake County 85 and GoTriangle in 2016. Brett Martin added that there is a committee comprised of representatives throughout Wake County that are reviewing and commenting on the scope of the Wake County Transit 86 87 Plan. Brett Martin stated that one of the outcomes of this review process would be to align the Wake 88 County Transit Plan with the 2050 Metropolitan Transit Plan (MTP). Brett Martin referenced the BRT and 89 the CRT investments and developments. Brett Martin added that the MTP development is going to kick 90 off in FY2020, and the MTP process itself will last 18 months. Brett Martin stated that the Wake County 91 Transit Plan will go to the GoTriangle Board of Trustees and the CAMPO Executive Board in June 2019. 92 Brett Martin stated that approximately \$160M of revenue has been accumulated from the transit tax. 93 Brett Martin stated that changes to the current transit system include: improvement of GoRaleigh services to Garner; GoCary operating the Holly Springs Express; GoWake Access is expanding service for 94 the elderly and disabled; and GoTriangle replacing Route 300. 95

96 ii. Durham County Transit Plan

97 Drew Cummings, Durham County

98 Drew Cummings stated that the key six (6) elements of the Durham County Transit Plan are: (1) 99 county leaders believe that they should have significant input in the expenditure of the county-wide 100 half-cent sales tax; (2) county leaders believe that there are county-level interests that are distinct from 101 urban interests; (3) recognition that numerous decision-makers present challenges to delivering 102 efficient, coherent transit policy and projects within and across county lines; (4) a new plan to simplify 103 and clarify processes rather than adding complexity; (5) a new plan and planned development process 104 to reflect more and better public input; and (6) a new plan and development process reflect as strength-105 based approach where each partner agency contributes most based on its particular strengths.

106 iii. Orange County Transit Plan

107 Travis Myren, Orange County

108 Aaron Cain, DCHC MPO

109 Aaron Cain stated that, following the discontinuation of the D-O LRT, the DCHC MPO would be

110 facilitating projects between Durham and Orange counties. Aaron Cain continued that the Joint Durham-

- 111 Orange Staff Working Group (SWG) made a FY19-20 Work Plan in May 2019. Aaron Cain stated that the
- 112 SWG plans to make recommendations on whether the Work Plan will go to the GoTriangle Board of
- 113 Trustees for adoption. Aaron Cain mentioned the new Alamance-Hillsborough connector and the Cedar
- 114 Grove to Durham Express Route.
- 115

5. Key Regional Efforts – "Lightning Round" Status & Engagement

116 **i. Regional Tolling**

117 Andy Henry, DCHC MPO

118 Andy Henry stated that the objective of the Regional Tolling Study was to identify projects to 119 add to the 2050 Metropolitan Transportation Plan. Andy Henry stated that the Regional Tolling Study reviewed ten corridors in the Triangle region, and I-40 comprises three corridors out of the ten total 120 corridors. Andy Henry explained that each corridor was measured by: projected revenue; travel time 121 122 savings; trip dependability; transit supportiveness; number of transit routes; impact on low income resident; and access to jobs. Andy Henry added that each of the ten corridors have their own fact sheet. 123 124 Andy Henry stated that presentations have been given to DCHC MPO Board and the CAMPO Board as 125 well as the North Carolina Turnpike Authority. Andy Henry continued that presentations are planned for 126 WakeUp Wake County, the Regional Transportation Alliance, and the Board of Transportation local 127 division offices. Andy Henry stated that more information can be gathered at triangletollingstudy.com. 128 Ellen Reckhow and Andy Henry discussed High Occupancy Vehicle (HOV) lanes. Andy Henry and 129 Wendy Jacobs discussed proposed funding. Andy Henry added that any corridors using tolling would 130 first need to be added to the Long Range Plan and then go through the SPOT process.

131 ii. Regional Intelligent Transportation Systems

132 Cheryl Lawrence, NCDOT

133 Cheryl Evans stated that the objectives of the Intelligent Transportation Systems (ITS) Strategic Plan were: to update the 2010 architecture; asses the needs, gaps and opportunities of the region; and 134 135 to meet federal requirements. Cheryl Evans added that the final workshop will be conducted on 30 May 136 2019, and the ITS Strategic Plan will be completed by the end of June. Cheryl Evans stated that ITS 137 provides effective, innovative and seamless integrative services to enhance safety, mobility, reliability, and interoperability through ITS solutions. Cheryl Evans mentioned some of the needs, gaps, and 138 139 strategies to fill the gaps, which were all discussed over the course of the ITS Strategic Plan. ii. Triangle Trails Initiative & Triangle Bikeway 140 141 Kenneth Withrow, CAMPO Sig Hutchinson, CAMPO 142 Kenneth Withrow stated that the Triangle J Council of Governments (TJCOG), CAMPO, and DCHC 143 144 MPO all received grants from the Safe Routes to School. Kenneth Withrow stated that DCHC MPO and 145 CAMPO participated in the non-motorized volume data program. Kenneth Withrow stated that an idea for a regional bike app occurred at the Triangle Bicycle Pedestrian workshop on March 29. Kenneth 146

147 Withrow added that there will be a cross Triangle Greenway bicycle outing on June 8 and encouraged

148 participation. Kenneth Withrow stated that the Bike Summit on October 19 and 20 produced an idea of

149 having cross connectivity through the heart of the Triangle region and it be incorporated into the Unified

150 Planning Work Programs (UPWP).

151 Sig Hutchinson stated that the Triangle Bikeway Initiative is a joint effort with CAMPO and DCHC 152 MPO and will begin in 2020. Sig Hutchinson added that its goal is to connect Wake and Durham 153 counties, which will ultimately connect to Orange County. Sig Hutchinson explained that the Triangle 154 Trails Initiative is to promote the Regional Greenway System with the assistance of Chuck Flink. Ellen 155 Reckhow recommended that John-Hodges Copple be involved due to his work with the Durham-Wake

- Work Group. Sig Hutchinson added that the East Coast Greenway is an initiative that runs from Maine toMiami, of which 70 miles are located within the Triangle region.
- 158

6. Federal Transportation Issues

159 i. Federal Funding

160 Leigh Wing, NCDOT DOT STIP Unit

161 Leigh Wing stated that there are three ways to lose federal funding; funds that have lapsed, 162 federal rescission, and not maximizing the August redistribution. Leigh Wing stated that funds are lost if they are not obligated within four years of receiving them from the federal government. Leigh Wing 163 164 explained that Congestion Mitigation and Air Quality Improvement Program (CMAQ), Transportation 165 Alternatives Program (TAP), and Transportation Alternatives Program Direct Attributable (TAP-DA) are 166 subject to rescission, whereas Surface Transportation Block Grants (STBG) and Surface Transportation 167 Block Grants Direct Attributable (STBG-DA) are not subject to rescission. Lee Wing stated that TAP 168 funds can be used for Americans with Disabilities Act (ADA) facilities.

169 Leigh Wing stated that it was estimated that North Carolina could lose approximately \$135M in 170 unobligated funds through federal rescission. Leigh Wing stated that there will be less funding lost in 171 federal rescission if more funding is obligated by the end of FFY19. Leigh Wing stated that the biggest 172 challenge is obligating TAP, TAP-DA, and CMAQ projects. Leigh Wing stated that NCDOT STIP (State 173 Transportation Improvement Program) Unit has been encouraging the MPOs throughout the state to 174 program eligible TAP-DA and CMAQ projects in earlier calls for projects. Leigh Wing stated that 175 programming the projects is required, but they must be obligated in order to avoid federal rescission. 176 Leigh Wing recommended to use less flexible funds first, specifically TAP and TAPDA. Leigh Wing explained that North Carolina receives approximately \$1.1B in federal funding for apportionment. Leigh 177 Wing explained the process of Obligation Authority (OA) and a 'fund swap.' Leigh Wing and Damon 178 179 Seils discussed the discretion of the NCDOT STIP Unit has in choosing projects for the 'fund swap.'

180 ii. Federal Rescission

181 Gretchen Vetter, CAMPO.

182	Gretchen Vetter explained CAMPO's strategies for avoiding a federal rescission of funding.
183	Gretchen Vetter stated that CAMPO has been working with the Technical Committee (TC), Executive
184	Board, CAMPO Local Projects Manager, NCDOT partners and Federal Highway Administration (FHWA).
185	Gretchen Vetter explained that CAMPO has reviewed the locally administered projects programs, and
186	noted projects that will be able to reach their funding deadlines and obligate within FFY19. Gretchen
187	Vetter added that shovel-ready projects are also chosen and submitted to the local Executive Board for
188	decisions on funding authorization. There was discussion about if funds in the FTA fund balance, but
189	not in an active grant, are still eligible for federal rescission. Gretchen Vetter and NCBOT Chairman
190	Mike Fox discussed Title 23. Mike Fox mentioned that North Carolina has previously leveraged as much
191	as approximately \$160M in redistribution.
192	7. Updates from Strategic Partners

193 i. GoTriangle

194 Jeff Mann, GoTriangle

- Jeff Mann stated that, due to the discontinuation in the D-O LRT, the Orange County and
 Durham County Transit Plans will need to be updated, and thanked local partners for their support. Jeff
 Mann also discussed project designs and routes for the Durham-Wake CRT project.
- 198 **ii. NCDOT Division 5**

199 Joey Hopkins, NCDOT Division 5

200 Joey Hopkins stated that CAMPO has approximately \$1.5B in active construction projects, and

201 thanked local partners who helped support the projects with the public. Joey Hopkins stated his

- 202 support of the BRT projects in development. Joey Hopkins stated that the East End Connector in
- 203 Durham County is projected to be finished in early 2020. Joey Hopkins stated that, due to the

discontinuation of the D-O LRT, alternative plans for NC 54, US 15-501, and the Durham Freeway are

205 planned to be discussed with the public

206 iii. NC Board of Transportation

207 Mike Fox, Chair of the North Carolina Board of Transportation

- 208 NCBOT Chairman Mike Fox stated that the Joint DCHC MPO and CAMPO meeting is a positive
- 209 step for transportation within the Triangle region.
- 210 iv. Regional Transportation Alliance
- 211 Joe Milazzo, Regional Transportation Alliance
- Joe Milazzo stated that partnership within the region has continued to help with transportation
- 213 throughout the Triangle region. Joe Milazzo mentioned the NC First Commission that NCDOT Secretary
- 214 James Trogdon advised. Joe Milazzo also invited participation in the tour to Richmond, VA, and
- 215 northern VA, and mentioned registration instructions are found at letsgetmoving.org/tour.

Amendment to the Orange County Transit Plan Regarding Funding for the Chapel Hill North-South Bus Rapid Transit Project

The Parties to the Orange County Transit Plan agree to amend the Plan as follows:

The Orange County Transit Plan shall be amended to provide up to \$8 million in additional dedicated transit revenue to the Chapel Hill North-South Bus Rapid Transit (NSBRT) Project. The additional \$8 million shall be allocated over four years to meet project funding requirements. The Plan shall be amended to dedicate \$1 million in FY20, \$1.5 million in FY21, \$1.5 million in FY22, and \$4 million in FY23. This funding is in addition to \$6.1 million allocated in the 2017 Orange County Transit Plan and increases the total amount dedicated to the North South Bus Rapid Transit Project to \$14.1 million.

This amendment is intended to provide the Town of Chapel Hill with evidence that fifty percent (50%) of the non-federal match is dedicated to the project through the Transit Plan. The total project cost is \$140 million.

The Town of Chapel Hill shall seek offsetting project funding through the North Carolina Department of Transportation's Strategic Prioritization Process (SPOT 6.0). To the extent that State funds or other public, non-profit, or private funds are awarded to the North South Bus Rapid Transit Project, these outside funds shall be applied to reduce the financial obligations contained in the Amended Orange County Transit Plan, up to \$8 million. Outside funding may not be used to finance changes in the project scope, unanticipated cost overruns, or other changes until the Transit Plan's obligation of \$8 million is completely relieved, unless otherwise approved by the parties to the Transit Plan.

To the extent that any portion of this amendment conflicts with elements of the 2017 Orange County Transit Plan, the terms of this amendment shall supersede those elements.

WHEREAS, projects listed in the TIP are also included in the State TIP (STIP) and balanced against anticipated revenues as identified in both the TIP and the STIP; and

WHEREAS, the North Carolina Department of Transportation and the MPO Board have determined it to be in the best interest of the Urban Area to amend the FY 2018-2027 Transportation Improvement Program as described in the attached sheets; and

WHEREAS, the United States Environmental Protection Agency Designated the DCHC MPO from nonattainment to attainment under the prior 1997 Ozone Standard on December 26, 2007; and

WHEREAS, the DCHC MPO certifies that this TIP amendment is consistent with the intent of the DCHC MPO 2040 Metropolitan Transportation Plan (MTP); and

WHEREAS, in accordance with 23 CFR 450.326 (d), the TIP shall include, to the maximum extent practicable, a description of the anticipated effect of the TIP toward achieving the performance targets identified in the metropolitan transportation plan, linking investment priorities to those performance targets; and

After consultation with management at NCDOT, the Division of Planning and Programming is adjusting the schedule for the next State Transportation Improvement Program (STIP) release which will be the future 2023-2032 STIP. The result of this schedule change will create a one-time three-year gap in the creation of the STIP. This adjustment will extend the Prioritization 6.0 (P6.0) project scoring process and the future Draft 2023-2032 STIP will be released in January 2022.

As you know, the Department has employed the assistance of many private engineering firms to actively work towards better cost estimates for all projects evaluated in the Strategic Prioritization (SPOT) process. This adjustment in the STIP release allows additional time for the completion of more Express Designs, resulting in better refined project scopes and cost estimates. Additionally, it allows extra time for coordination of project submittals between our MPO/RPO partners and NCDOT Divisions, as well as further validation of the P6.0 scoring data.

Bye bye Bird and Lime. New electric scooters arrive in Raleigh this week.

A new electric-scooter company is set to arrive in Raleigh as Bird and Lime end their rocky relationship with the city.

Gotcha, a South Carolina-based company, will arrive with a fleet of about 150 scooters this week, with plans to add more. It and the city of Raleigh will hold an event from 11 a.m. to 4 p.m. Monday at Exchange Plaza, between Fayetteville and Wilmington streets, in downtown to introduce the scooters to the public.

"The most important thing is to give us a shot," said Sean Flood, CEO of Gotcha. "Whether you've had a great experience or not great experience with the last scooters, give us a chance. Be open to the benefits of the product and be open-minded about a new company."

Bird and Lime arrived unannounced in Raleigh last year, instantly polarizing the city between those who welcomed the new mode of transportation and those who saw the vehicles as a nuisance.

"I think you'll see how they come into the market, it's a little bit more thoughtful and measured," said Michael Moore, the city's transportation director. "It's not all shock and awe."

DESIGNATED PARKING ZONES

Gotcha scooters are similar to Bird and Lime in that it costs \$1 to "unlock" the vehicle and 15 cents per minute to ride. However, riders will be incentivized to park the blue scooters in designated parking zones — Flood said riders may be charged more if they don't park in one — instead of leaving them wherever they finish their ride. Those zones are still being set up, he said, adding some riders will have to "change behaviors."

Gotcha doesn't want to be in every market, Flood said, adding the company plans to work in cities and at universities where they are the exclusive scooter company. They've looked at places where there are multiple companies offering scooter services and are pulling back in some, he said. Gotcha left the city of Nashville within the last week.

After BIrd and Lime arrived, the city's staff recommended rules and a \$100 per scooter fee, which the Raleigh City Council increased to \$300 per scooter. It's one of the highest per-scooter fees in the country.

The fee is high, Flood said, but added that Gotcha is committed to Raleigh and hopes the company and the city will be able to work together to make sure the scooters are affordable to residents while still being profitable.

The two California-based companies, Bird and Lime, did not apply to operate in the city, citing the city's fees and regulations. They left at the end of July.

The city could have picked four companies to replace Bird and Lime, but only selected Gotcha. The company will be allowed 500 scooters with the potential of 1,000 — though Flood said the company's standard fleet is normally 250 to 450. If Gotcha is allowed to deploy 1,000 scooters, it would still fall short of the nearly 1,400 scooters that were in the city at one point.

Gotcha will also have local employees who pick up the scooters for charging and maintenance instead of relying on contracting with residents to pick up the scooters.

LIME TO REMAIN AT NC STATE

In an outgoing message to the city, Lime thanked its team of chargers (called juicers) and riders for being apart of the "Lime family" and regrets not being able to stay. The company will still be at N.C. State University.

"After months of conversation and attempts to find a suitable path forward with the city of Raleigh, we were unable to reach an agreement that would allow for the sustainable, well-run scooter program Raleigh residents deserve," Lime said in a statement. "We regret that we will not be able to serve Raleigh at this time and we thank our riders and our

great team of juicers for being a valued part of the Lime family. We hope to serve Raleigh in the future so residents can enjoy our reliable, sustainable and affordable transportation options."

In an email to riders, Lime said people should vote for "candidates who value alternative transportation" in the upcoming municipal election if they want Lime scooters to come back.

"Bird is so grateful to our Raleigh community for supporting shared e-scooters and embracing Bird as an environmentally friendly alternative to short car trips," Bird said in a statement. "Unfortunately, due to burdensome regulations on e-scooter providers, it no longer makes sense for us to provide our service in the city. We thank Raleigh riders and would welcome the opportunity to provide our service again in the future under improved circumstances."

As gas tax withers, how will NC pay for roads, sidewalks and bike paths in the future?

Most of the N.C. Department of Transportation's annual \$5 billion budget comes from people who use the state's roads, through taxes on gasoline and the sale and registration of cars and trucks.

But what if many people — perhaps a majority — don't pay those taxes, because they drive electric vehicles that don't use gasoline or because they use ridesharing services such as Uber and Lyft and don't own a car.

The NCDOT is trying to prepare for those and other possible scenarios where the current way of paying for the state's transportation system may no longer work, because of changes in technology, demographics and travel habits.

The department has formed a committee of business people, politicians, economists and others to explore alternative strategies for paying for transportation. The N.C. FIRST Commission will meet over the next year and is looking for some guidance from the public through an online survey, at publicinput.com/ncfirst.

Government has built and maintained roads and other transportation systems mostly using fees and taxes paid by the people who use them. The biggest single source of revenue is the gas tax: The state tax of 36.2 cents per gallon accounts for 40% of NCDOT's budget, while the federal gas tax of 18.4 cents a gallon provides the bulk of the federal money that makes up 25%.

The "highway use tax," which is essentially a 3% sales tax when a vehicle's title changes hands, and Division of Motor Vehicle registration fees account for most of the rest of the budget.

The gas tax has already become less dependable as a source of revenue, as improved mileage means people pay less in taxes to drive the same distance. Improvements in battery storage and reductions in cost are expected to make electric vehicles more attractive to consumers in coming years, reducing gas tax revenue even further.

"We've always been a user-pay system," says Burt Tasaico, NCDOT's director of strategic initiatives and program support. "The challenge is, how can we maintain that in light of all the changes that we see?"

Other changes on the horizon include autonomous vehicles. While Ford CEO Jim Hackett recently said carmakers have been overly optimistic about the development of self-driving cars, the industry still predicts their arrival in years, rather than decades, which could also lead to drastic changes in vehicle ownership.

Tony Seba, a Silicon Valley entrepreneur who heads a think tank called RethinkX, predicts that by 2030 nearly all of the road miles traveled in the U.S. will be provided by on-demand autonomous vehicles owned by fleets, in a new business model he calls "transport-as-a-service." And those vehicles will all be electric, Seba says.

N.C. Secretary of Transportation Jim Trogdon cites Seba in explaining why he created the FIRST Commission (Trogdon has invited Seba to speak at next year's transportation summit in Raleigh). He notes that others think the transition to fleets of on-demand, all-electric vehicles will take longer to come about, but the point is the state needs to be ready for some dramatic changes.

"Even if we're 50% correct, we're still better off," Trogdon said in an interview. He added that even some of the most fantastic scenarios for transportation in the future involve pavement.

"Unless everyone is flying in unmanned aerial vehicles, I would anticipate that we're still going to need roads," he said.


The shift to electric vehicles will likely be gradual, giving the state time to adjust, says Amna Cameron, NCDOT's deputy director of strategic initiatives and program support. When the FIRST Commission makes recommendations to the General Assembly ahead of the 2021 session, Cameron said, she expects they will include some modest proposals to boost transportation revenue, such as taxes on Uber and Lyft or on electric scooters.

"We are not at a crisis point in terms of any revenue stability," she said. "This will be a phased-in plan."

The FIRST Commission's public survey, which will be open through the end of the month, asks which new sources of revenue the commission should consider and provides six choices: a fee based on vehicle weight; a variable fee based on congestion; a dedicated state sales tax; a fee based on miles traveled; a sales tax on motor fuel; and a tax on electricity.

It also leaves a space for people to suggest their own ideas.

The commission's name is an acronym: Future Investment Resources for Sustainable Transportation. It is led by Raleigh Mayor Nancy McFarlane and Ward Nye, president and CEO of Raleigh-based Martin Marietta, which provides stone, gravel, cement and other materials for road and other construction projects.



Electric scooters are coming to Durham. What you need to know before they land.

Durham is about to join the electric scooter craze.

Four companies, Bird, Lime, Gotcha and Spin, will be allowed to bring up to 200 electric scooters each to the city starting Thursday, June 13.

"We are pleased that residents and visitors in Durham will have a new transportation option to try. Scooters can provide first- and last-mile connections to transit and serve residents who don't have a car or prefer to drive less," Interim Transportation Director Bill Judge said in a statement.

"Ultimately, this is one way we're working to provide equitable, accessible, multi-modal transportation services that meets the needs of our growing community and consumer demands," Judge said.

The length of the trip and each company's policies will affect the cost of each ride, but Evan Tenenbaum with the city's Department of Transportation says all companies charge \$1 to initially unlock a scooter.

"We should have them throughout the central part of Durham, near downtown, NCCU, Duke, Ninth Street area, east Durham, etc.," Tenenbaum said. "We will have a map on our website sometime next week for locations people can expect to find scooters parked in the mornings."

The Durham City Council began preparing for electric scooters last fall. It approved a permitting process for scooters that eventually will also apply to other methods of transportation, like bicycles and electric bicycles.

The city requires scooter companies to keep 20% of their fleet in areas accessible to low- and moderate-income residents and to provide a payment method that doesn't depend on smart phones or credit cards.

Riders, who must be older than 16 and are encouraged to wear helmets, are not allowed on sidewalks, according to the city's rules.

According to Judge, Durham's recent bike-share pilot program showed demand for alternative ways of getting around the city.

Over 61,000 trips were completed when the program was operating, with riders accumulating over 50,000 miles during the pilot period, according to a news release. The operators, Spin and Lime, removed their bikes earlier this year and are now focused on e-scooters, the release said.
