Subject: FY 2020 Unified Planning Work Program – Amendment #1

The Lead Planning Agency (LPA) staff is requesting an amendment to the FY2020 Unified Planning Work Program (UPWP). The proposed amendment is necessary in order to reflect the following:

- Addition of STBG-DA funds by Town of Hillsborough.
- De-obligation of STBG-DA funds by City of Durham.
- Reallocation of STBG-DA funds among task codes by Durham County.

The UPWP provides yearly funding allocations to support the ongoing transportation planning activities of the DCHC MPO. The UPWP must identify MPO planning tasks to be undertaken with the use of federal transportation funds. The proposed revisions are illustrated in amendment tables below.

The addition of funds for the Town of Hillsborough will allow for a planning study to develop conceptual alternatives for a potential new public road connecting Eno Mountain Road and NC 86 in Hillsborough.
