2050 MTP Public Engagement Plan and Schedule (10 minutes) **Andy Henry, DCHC MPO**

The DCHC MPO Board released the draft Public Engagement Plan and schedule for the 2050 MTP at their June meeting for a minimum 42-day public comment period. The Board conducted a public hearing at their August meeting but no one from the public spoke on this particular agenda item.
